



OGGOLAANSHO ISTICMAALKA FOOMKA LA-SOCOSHO "SE MEG"

Qaybta xannaanada carruurta ee degmada Kristiansand waxay rabtaa inay dhammaan carruurta dhigata xannaanada carruurta u isticmaasho foomka la-socoshada "Se meg".

Buuxinta iyo isticmaalka foomka waa ka-baarandegga warbixinta shakhsiga ah ee cunugga, sidaas awgeed waxaa la weydiisanayaa dadka ka mas-uulka oggolaansho, sida uu qabo sharciga warbixinta shakhsiga ah. Waa ikhtiyaari oggolaanshaha isticmaalka foomka.

Foomku wuxuu noqonayaa dokumentiga cunugga waxaana loo isticmaalayaa la socodka cunugga shakhsiga ah. Waxaa ka mid ah waqtiya la isticmaali karo markii wareysi lala leeyahay waariddiinta.
